Subject: Grant of ex-servicemen status to recruits boarded out on medical grounds with disability pension.

I am directed to invite your attention towards Government letter No. 12/99/85-2GSII, dated 08.11.88 on the subject noted above vide which it was decided to include following categories of territorial personnel of Army the definition of Ex-servicemen:-

- 1) Pension holders for continuous embodied service;
- 2) Persons with disability attributable to military service; and
- 3.) Gallantry Award winners.

2. On reconsideration of matter, Government have decided that such recruits who were boarded out/released on medical grounds and granted medical/disability pension shall also be covered under the category of ex-servicemen for all practical purpose.

3. This issues with the concurrence of the Finance Department conveyed vide their U.O. No. 2/54/07-IP, dated 28.12.2007.

These instructions shall be applicable from the date of issue and the same be brought into the notice of all concerned for compliance.
